

IMPORTANT NOTICE FOR SAVINGS AND SALARY ACCOUNT HOLDERS

With effect from 1st August 2020, Cash Transaction fees are being revised/introduced as below:

a) Introduction of Third Party Cash transaction Fee:

b) Introduction of Cash Handling Fee:

Cash Handling	NA	Rs.100/- per bundle (1000 notes*) on lower denominations notes of Rs.10/20/50 only.

c) Revision of BNA convenience Fee for accounts not meeting Product Balance requirement/TRV:

*TRV of Month end at Customer ID level/Balance of Rolling Month/Quarter

Note: Axis BNA transactions are charged only after banking hours (i.e. Between 5:00 pm to 9:30 am) and on National and State level Bank Holidays

Exclusions – Burgundy, Burgundy Private, Defence Salary Accounts, NR schemes, Axis Republic Salary, Basic/Small Savings/Pension Account, Trust Schemes

d) Rationalizing limits for Axis Republic Salary Account:

Cash transactions	Free First 10 transaction or Rs.10 lakh whichever is earlier, Above Free limit - Rs.5/1000 or Rs.150, whichever is higher	Free First 5 transaction or Rs.2 lakh whichever is earlier, Above Free limit -Rs.5/1000 or Rs.150, whichever is higher
